#### Apply for FEMA Assistance If Your Home Is a Boat

If your home is a boat, you may qualify for FEMA assistance. Please use the physical and complete address of the dock or marina and the slip or mooring number, if the boat was not located on private property.

#### Deadline to Request for Public Assistance Extended to Jan. 6, 2023

State and local governments, community, and volunteer organizations affected by Hurricane Ian have until Jan. 6, 2023, to submit their requests to the state for public assistance.

#### FEMA Direct Housing Assistance in Seven Counties

- FEMA is providing direct temporary housing assistance in seven counties in Florida: Charlotte, Collier, DeSoto, Hardee, Lee, Sarasota and Volusia,
- This assistance includes direct lease of residential properties, repair of existing vacant multi-family
  properties for use by survivors, and travel trailers or manufactured housing units.

#### More Applicants Qualified as More Types of Documents Accepted

- FEMA now accepts more types of documents to verify ownership and occupancy, and also accepts documents from a wider range of dates.
- Additional 11,600 survivors of Hurricane Ian have received more than \$140 million in assistance that they
  otherwise would not have been eligible to get.

#### Advance Payment in National Flooding Insurance Program

Contact your flooding insurance agent or company to see if you can receive an advance payment to help jumpstart your recovery.

 Policyholders of National Flooding Insurance Program affected by Hurricane Ian may receive \$5,000-\$20,000 with documentation, before an adjustor visits.

#### SBA Waives Interest Rate for First Year on New Disaster Loans

The U.S. Small Business Administration will waive the interest rate for the first year on new disaster loans and extend the initial payment deferment period automatically to 12 months.

#### One Disaster Recovery Center in Lee County Temporarily Closing on Dec. 13

- The disaster recovery center at the Estero Council Chambers, 9401 Corkscrew Palms Circle Estero, Lee County, Florida, will be closed on Dec. 13, because of a previously scheduled event.
- Other than Dec. 13, this center is open Monday through Saturday, 8 a.m. to 7 p.m., closed Sundays.

#### FEMA Mitigation Funds to Help Rebuild Stronger

Homeowners who are eligible for Individuals and Households Program assistance may receive additional mitigation funds from FEMA to reduce damage losses. Specific mitigation measures may include:

- Roof repair to withstand higher winds and help prevent water infiltration.
- Elevating a water heater or furnace to avoid future flood damage.
- Elevating or moving an electrical panel to avoid future flood damage.

#### FEMA Speaks Your Language

If you speak little or no English, you will be shown a language identification guide with the phrase "I Speak ..." in many languages. You can point to the language you understand, and the FEMA representative can connect to an interpreter who speaks your language.

#### **Deadline to Apply for FEMA Assistance Extended**

At the request of the state of Florida, FEMA has extended the deadline for Hurricane Ian survivors to apply for assistance to Jan. 12, 2023. Homeowners and renters in the following counties can apply: Brevard, Charlotte, Collier, DeSoto, Flagler, Glades, Hardee, Hendry, Highlands, Hillsborough, Lake, Lee, Manatee, Monroe, Okeechobee, Orange, Osceola, Palm Beach, Pasco, Pinellas, Polk, Putnam, Sarasota, Seminole, St. Johns and Volusia counties.

#### **Public Assistance for Houses of Worship**

Florida houses of worship and other private nonprofit organizations may be eligible for FEMA assistance to help pay for emergency protective measures, debris removal and restoration of facilities damaged by Hurricane Ian. Houses of worship should contact their county emergency management office for more information on how to submit a FEMA request for Public Assistance.

#### **Protect Yourself from Identity Theft**

If a FEMA inspector visits your home but you have not applied for FEMA assistance, or if you receive a letter from FEMA without submitting your FEMA application, you may be a victim of identity theft. If so, please inform the FEMA inspector or call FEMA Helpline at 800-621-3362 to stop the application process. #### **Derelict Vessel Waiver Process**

If your boat is unsalvageable after Hurricane Ian, consider releasing ownership through the vessel waiver process. This allows for the removal and destruction of the vessel for no cost. Since many residents are still assessing damages, the waiver acceptance deadline has been extended from through the end of the year. #### **Hurricane Nicole**

Residents in areas affected by Hurricane Nicole should follow directions from local authorities concerning cleanup and safety after the storm. If you had damage from Hurricane Nicole, contact your insurance company, take pictures of the damage, begin clean-up, and save your receipts. Hurricane Nicole has not received a major disaster declaration at this time, and FEMA is not accepting applications for assistance related to Nicole. If you need assistance for loss resulting from Nicole, you can contact community-based services such as 211, the Salvation Army, Catholic Charities and others. #### **Substantial Damage Determinations**

Local community officials are required to inspect disaster-damaged structures in Special Flood Hazard Areas to meet the requirements of the Florida Building Code and the community's floodplain management regulations. If the cost of repairing the structure to its condition before Hurricane Ian is 50 percent or more of its pre-disaster market value, the house or building is considered "substantially damaged." FEMA does not make substantial damage determinations; the determination is made by a community's building official or floodplain manager. Repairing a structure in a floodplain requires a permit. Survivors have options to bring the structure into compliance with the Florida Building Code and the community's floodplain management regulations.

#### **Temporary Housing for Survivors**

FEMA is providing grants for basic repairs to homes damaged by the storm, rental assistance for those who can't remain in their homes and hotel stays for survivors who can't find a place to rent. This support is available in all 26 counties approved for FEMA Individual Assistance.

#### **FEMA Is Hiring**

FEMA is conducting local hiring for more than 300 jobs in Brandon, Fort Myers, Kissimmee, Orlando and Sarasota. The agency is seeking people with experience in customer service, logistics, environmental protection, engineering, emergency management and other job categories. #### Flood Insurance Policyholders Given Additional Time to Renew

National Flood Insurance Program (NFIP) policyholders in Florida affected by Hurricane Ian can renew their recently expired policies without the consequence of a lapse in coverage. The renewal extension applies to policyholders whose flood insurance policy expiration was between Aug. 25 and Oct. 23. FEMA has also extended the proof of loss requirement for Florida flood insurance policyholders who experienced flood damage from Hurricane Ian from 60 to 365 days. Contact your insurance agent or insurance company to discuss your policy. If you do not have this information, call the NFIP at 877-336-2627.

#### SBA Loans Can Help Your Recovery

The U.S. Small Business Administration has approved \$1.2 billion in federal disaster loans to survivors impacted by Hurricane Ian. The deadline to apply for physical disaster loans from SBA has been extended to Jan. 12, 2023. Long-term, low-interest disaster loans for homeowners, renters, businesses and nonprofit organizations from SBA are available to cover losses not fully compensated by insurance and other sources. Business Recovery Centers are operating in impacted areas.
